Types of Gifts You Can Leave:

1. Residuary Bequest: A percentage or the remainder of your estate after all other bequests and expenses have been paid.
2. Pecuniary Bequest: A specific sum of money.
3. Specific Bequest: A particular item, such as real estate, shares, or valuable personal property.
4. Percentage Bequest: A specific percentage of your entire estate.

How to Include DRA in Your Will:

1. Decide on the Type of Gift: Consider what type of bequest you would like to make.
2. Consult a Legal Advisor: Speak with a solicitor or legal advisor to ensure your wishes are clearly articulated and legally binding.
3. Include DRA's Details: Ensure the following information is included in your will:
4. Legal Name: Disaster Relief Australia
5. ABN: 44 614 474 010
6. Registered Address: 1/299 Elizabeth Street, Sydney, NSW 2000

Suggested Wording for Your Will:
